4. Michigan Liquid Asset Fund Plus:

The Board was presented with information on the opportunity to join the Michigan Liquid Asset Fun Plus (Mi-LAF+) investment pool with funds received from the bond sale. The Board had the opportunity to ask questions and discuss the information provided.

5. Bid-Temperature Control:

A bid to replace existing Middle School and High School Temperature Controls was presented to the Board for consideration and discussion.

6. Policy Update:

The fall policy revisions recommended by NEOLA were reviewed by the Policy Committee on November 18<sup>th</sup>, 2024 and provided to the Board for consideration and discussion.

7. Excellence in Education:

A meeting was held on December 2<sup>nd</sup>, 2024 with a group of teachers and administrators from McComb Elementary and Caro Middle School, as well a committee of the Board, to discuss the services that the Institute for Excellence in Education has provided to the District in the past and the discussion of additional services for select buildings. He also shared that the District received notice of receiving a state EGLE grant for \$47,000 that will be used toward the Filter First Safe Drinking Water program requirements set by the state.
