Instructions for Scholarship Application

- 1. The attached application is to be used for the Pat Curtis Chevrolet Auto Body and Technician Scholarship offered through the Tuscola County Community Foundation. One (1) \$750 scholarship is available to be awarded to a graduating senior from a TISD service area, parochial school student, home school student and/or Tuscola County resident attending an accredited high school outside Tuscola County, who is pursuing a career requiring post-secondary education program in an automotive technician or auto body program leading to certification. High School GPA will be a consideration.
- 2. The scholarship award shall be distributed to the post-secondary institute selected by the scholarship recipient.
- 3. Applications and required attachments must be postmarked by March 15, 2025 to:

- 4. Applications are to be typed (12-point font) or legibly printed in ink and must be signed by the applicant. Applications not signed will not be considered.
- 5. Submit the original application and one official high school transcript along with four (4) copies of each (including letter of recommendations and any attachments). Please have original printed single sided and no staples.
- 6. Attach to the application and each of the four (4) copies of the application a one-page essay (double-spaced, 12-point font) addressing personal and educational goals in the next five (5) years.
- 7. Recipient (parent/guardian if recipient is not 18 or older) must consent to having name and image likeness included in public/media releases. Scholarship pays directly to post-secondary school if applicant is awarded this scholarship.
